# **Proposal for Flood Relief 2020**



### Introduction:

Nepal is one of the most disaster-prone countries in the world because of its rugged topography and climatic conditions. It is ranked fourth in terms of vulnerability to climate change impacts and 11th for earthquakes. According to government reports, over 80 percent of the country's total population is at risk of natural disaster, putting Nepal among the top 20 most disaster-prone countries in the world.

As the world faces difficulties managing disasters while making efforts to slowing the spread of COVID-19, the monsoon rain in different parts of Nepal since the last week of June have triggered flooding and landslides in many parts of the country. However, the rainfall became more intense from the Mid-July 2020. The Nepal Department of Hydrology and Meteorology has predicted that rainfall will further intensify with increased water flow and current in rivers resulting in landslides and flooding.



According to the Nepal Red Cross Society(NRCS) situation report as of 20 July 2020, 412 families have been displaced in various districts and some 141 houses were fully destroyed. There are crucial needs for temporary shelter like tarpaulins and food items in the affected districts. Also, in case if there is possible inundation in the Terai region because of the excessive rainfall, there is a high risk of waterborne disease outbreaks.

#### **Request for Emergency Funding:**

As a response to the flood disaster amid the COVID-19 pandemic, the foundation proposes to continue the relief packages to flood disasteraffected families after its successful delivery of food support to 926 families affected by the four months long coronavirus lockdown in the Although Nepal country. the government has officially lifted the four-month-long coronavirus lockdown with conditions, people are



gradually returning to a new normal environment. However, following widespread floods and landslides triggered by the monsoon rain, which have affected several districts of the country since the last week of June, the number of casualties and damage is increasing.

The worst hit districts are Parbat, Lamjung, Gorkha, Kalikot, Syangaja, Gulmi, Bajhang, Darchula, Bajura, Sindhupalchok, Kasi, Myagdi and Jajarkot.



According to the last report of the National Disaster Risk Reduction and Management Authority, as of 22 July, 82 people have died, at least 74 are missing and 77 have been injured. In addition, the disaster has displaced 603 families, 1,199 have been affected and approximately 532 houses have been destroyed or damaged. The Nepal Disaster Risk

Reduction Portal reports 74 landslides and 15 flood events over the last week. And many of the aforementioned districts call for immediate emergency support including daily life necessities such as water, hygiene items, basic and supplementary food rations, emergency shelter and non-food items.



Hence, the DTCF is intending to provide relief kits in flooded districts where relief has not reached. The team is working on collecting details and coordinating with local units, youths, leaders, influencers, etc. of flood-affected districts.

As of today, the foundation's team is working on the first batch of the relief effort in coordination with Nijghad-Kathmandu Liaison Committee. In that area around 45 families need emergency shelters and the foundation plans to provide 2x3 ft long cement tiles to aforementioned number of families for roofing on temporary shelters the size of 10.5x16.5 ft or 16.2 Square Meters. Furthermore in the same area as well as in other flood affected districts there are many families in crucial need of shelter and food items as the monsoon rain and its impact is continuing.

Hence, any individual or organization willing to be part in this humanitarian aid, is invited wholeheartedly to support this cause. No donation is too big or small as any amount will help a family alleviate the difficulties in the face of natural disaster. So we earnestly and humbly request you to take part in this gift of support and togetherness in comforting the flood victims' families. Thank You.
